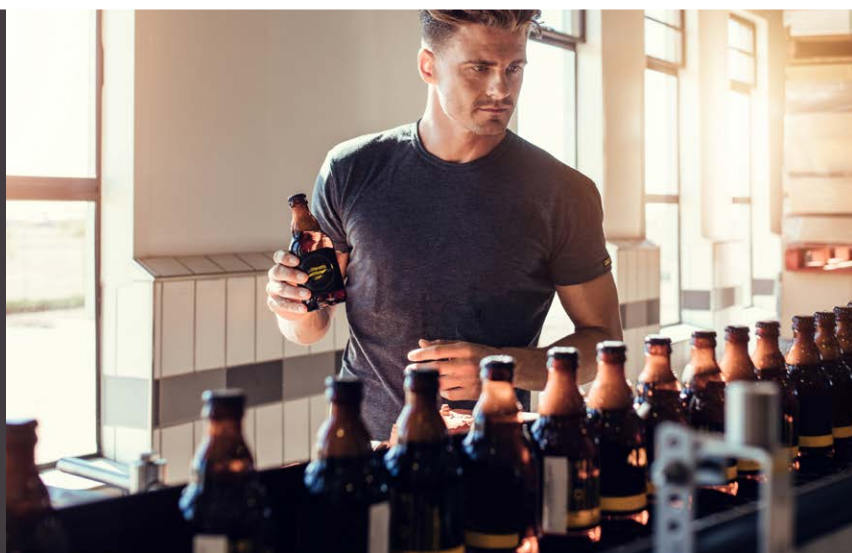

Production facility classes:

Fork Lift (2hours) Anyone operating a forklift in a Beverage production facility is required by CalOSHA to have a certification card on file. Passing a written test and skills evaluation will give the operator a new two-year forklift certification card.

Confined Space (1.5 hours) This CalOSHA required annual training for anyone who works with the cleaning and/or maintenance of tanks or any other identified confined spaces located in the production facility. During this class, we will demonstrate the use of a respirator and CO2 monitor with hands on practice of rescue techniques will be featured. Participants will receive a certificate of completion for their participation to present to their employer.

Lock out/tag out (LOTO) & production facility safety (1.5 hours) This CalOSHA required annual training is for all production workers and covers the safe use, repair and servicing of powered equipment. This LOTO training will comply with the CalOSHA "Authorized Employee Requirements". In addition, we will review other production facility safety issues including slip and fall hazards as well as chemical handling. Participants will receive a certificate of completion for their participation to present to their employer.



Tasting room classes:

First Aid/CPR (2 hours) Course follows current Red Cross curriculum for First Aid and CPR. We will cover basic First Aid and CPR techniques to stabilize an injured worker for first responders. Participants will receive a certification card valid for two years from the American Red Cross.

Responsible alcohol server (2 hours) This training will enhance the fundamental people skills of servers and sellers and alcoholic beverages. Tasting room personnel who participate in this training will be able to spot underage drinkers and prevent sales to minors, recognize the signs of intoxication, effectively intervene to prevent problem situations and handle refusal situations with greater confidence. Participants will receive a certificate of completion for their participation to present to their employer.

Management classes:

Sexual harassment (2 hours) This training complies with California's annually required awareness training under the sexual harassment and abusive conduct regulations. Please note, this course meets the minimum two hour management course and is designed for those in the workforce who manage employees. Participants will receive a certificate of completion for their participation to present to their employer.

Accident/Incident Investigations (1.5 hours) Investigating a worksite incident, fatality, injury, or close call provides employers and workers the opportunity to identify hazards in their operations and shortcomings in their safety programs. Most importantly it allows implementation of corrective actions to prevent future incidents. This training will focus on identifying and correcting root causes, prescribing preventative action, statement taking, questioning techniques, and documentation gathering.
