Classes

FORK LIFT (2 HOURS) Anyone operating a forklift in a winery production facility is required by CalOSHA to have a certification card on file. Passing a written test and skills evaluation will give the operator a new two-year forklift certification card.

First Aid/CPR We will cover current Red Cross curriculum for basic First Aid and CPR techniques to stabilize an injured worker for first responders. Participants will receive a certification card valid for two years from the American Red Cross.

SEXUAL HARASSMENT PREVENTION(1 HOUR) The ever-changing landscape regarding sexual harassment, workplace violence, and general harassment law is focusing heavily on preventative training regarding all tiers of employment. This class is designed to assist each company in the training of all non-management employees regarding your company's harassment policy. Participants will receive a certificate of completion for their participation to present to their employer.

LOCK OUT/TAG OUT (LOTO) & CONFINED SPACE (2 HOURS)

CalOSHA requires annual training for all winery production workers in LOTO/Confined Spaces. The LOTO will comply with the CalOSHA "Authorized Employee Requirements". Confined space training is for anyone who works with the cleaning and/or maintenance of tanks or any other identified confined spaces located in the production facility. During this portion, we will demonstrate the use of a respirator, CO2 monitors and hands on practice of rescue techniques. In addition, we will review other production facility safety issues including slip and fall hazards as well as chemical handling. Participants will receive a certificate of completion for their participation to present to their employer.
