CLASSES

CONFINED SPACE

An employer must conduct this CalOSHA required annual training for anyone who will make bodily entry into any confined spaces such as tanks and pits. During this session, we will demonstrate the use of a respirator, permitting process, atmospheric gas monitors. Participants will receive a Certificate of Completion for their participation to present to their employer.

FORKLIFT CERTIFICATION

Anyone operating a forklift in a winery is required by CalOSHA to have forklift operators' certificate on file verifying competency. After passing a written test and skills evaluation the operator will receive a Certificate of Competency valid for three years.

FIRST AID/CPR

Course follows current Red Cross curriculum for First Aid and CPR. We will cover basic First Aid and CPR techniques to stabilize an injured worker for first responders. Participants will receive certification card valid for two years from the American Red Cross.

LOCK OUT/TAG OUT (LOTO)

This CalOSHA annually required training for all winery workers covers the safe de-energization of powered equipment/machinery in the winery for the purpose of conducting service, sanitizing/cleaning, and repair work. This LOTO training complies with the CalOSHA "Authorized Employee Requirements".
