## Classes (all classes are in Spanish)

### TRACTOR/ATV SAFETY

This Train the Trainer Session will cover the items needed to certify Tractor/ATV operators in the agricultural industry. It will meet the Cal OSHA requirements for annual training. Certificates of completion will be provided.

### WPS - A9 PESTICIDE AWARENESS

This training is for employees who work in areas where pesticides are used as required annually by Department of Pesticides of Regulations (DPR).

### EMPLOYEE SEXUAL HARASSMENT PREVENTION

This training complies with the California Civil Rights Act that requires every 2 years awareness training under the SB 1343 sexual harassment and abusive conduct prevention and awareness SB 1343. This course is **NOT** for those who manage employees.

### SUPERVISOR SEXUAL HARASSMENT PREVENTION

This training complies with the California Civil Rights Act annually required training for agricultural workers under the AB 1825/2053 & SB 396 sexual harassment and abusive prevention training. This course meets the minimum two-hour management requirements and is designed for those in the workforce who manage employees. Certificates of completion will be provided.

### FORKLIFT (POWERED INDUSTRIAL TRUCK) CERTIFICATION & RECERTIFICATION

Anyone operating a forklift in a winery is required by Cal OSHA (T8 CCR 3650 & 3668) to have forklift operators' certificate on file verifying competency and authorization. After a classroom session, passing a written test and skills evaluation (must have previous experience) the operator will receive a Certificate of Competency valid for three years.
